Membership decisions are made by our Board and then ratified at Board Meetings.

There is an annual fee of £50.00 for current community landowners.* There is no membership fee charged for those organisations that are aspiring community landowners or those who have not yet acquired land.

** This fee has been waived for 2022.*

Full membership with Community Land Scotland is open to constituted groups representing geographic communities who either already own or who aspire to own land or buildings for the benefit of the community. As part of the application process, we may ask for a full copy of the organisation's governing documents.

Aspiring membership with Community Land Scotland is open to non-constituted organisations that are working towards Full Membership criteria. This membership will apply for 1 year and will be reviewed upon expiry of that period. Aspiring Members shall not be entitled to vote.
